## COVID-19 related

- We require each participant, adult and student, check their temperature. This can happen prior to arrival or on site if one forgets to do so at home. If someone has a temperature of 100.4° or greater, they need to stay home.
- If someone has symptoms of COVID-19, they need to stay home as well.
- We will keep a record of who attends this event.
- We will aim for good sanitation practices such as using hand sanitizer and we will encourage hand washing.
- The CDC categorizes activates such as Day Camps, which this fits within, in various levels of risk. This carries with it the 3<sup>rd</sup> level of risk which is described as "Even Higher Risk." The way they describe this risk level is this: "Campers mix between groups and do not remain spaced apart. All campers are from the local geographic area (e.g., community, town, city, or county)."
